Context and Background

Institute of Social and Policy Sciences (I-SAPS) with the help of Alif Ailaan is implementing the project *"Political Advocacy and Outreach Support for Transforming Education Pakistan (TEP)"* in Thatta District. The initiative aims to develop and present evidence based research products to wide stakeholders to help facilitate the demand articulation of the citizens to improve situation of education.

One of the important research products to be developed under the initiative is "Citizen Agendas for Education Reforms". The Citizen Agendas are developed in participatory manner with the users and important stakeholders of education service delivery in the respective districts. To take the input from the stakeholders, consultations were undertaken in District Thatta. Meetings were undertaken with the following stakeholders on 15th January 2014:

- District Education Officials
- Bar Council
- Politicians
- Civil Society Organiations

Recitation of the Holy Quran and Presentation on Situation Analysis of District Education Thatta

Proceedings of the consultations are presented one by one in the following. All meetings started with recitation of Holy Quran following which the presentation of the local education condition was shared with the participants.

Mr. Mukhtiar Zour briefed all participants on current situation and planning of education reforms initiated by I-SAPS and Alif Ailaan. Mr. Sadiq Tareen gave a comprehensive presentation on educational situation analysis of District Thatta. He shared that under this initiative, a detailed plan for five years will be developed and its implementation will also be facilitated. After the briefing on the situation of the District, the Consultant opened the forum for discussion.

Discussion Highlights of the Consultation with District Education Officials

DEO appreciated I-SAPS and Alif Ailaan initiative and efforts and told that there is a need of such nature of work for education reforms. Involvement of politicians and different influencing people in education to support the reforms are very important. He also said that if various stakeholders are involved in the education planning, they can be held accountable for their performance to improve the education situation.

Mr. Hozoor Bux Said that education is the basic right of every child and we will support to I-SAPS to make this happen.

Discussion Highlights of the Consultation with Members Bar Council

Mr. Soomar Samoon President Bar Council said that I-SAPS is the only organization that has taken this initiative and giving them honor and needs their contribution and cooperation in this work. He agreed with the facts and figures about situation of education in Thatta district shared by I-SAPS. Mr. Masood Shah said that education system of district Thatta is poor and ensured their support with Alif-Ailaan and I-SAPS for improvements in education. Mrs. Yasmeen said that non availability and absence of the

teaching and management staff within offices is the major issue. Mr. M. Hussain Shaikh said there are so many buildings that are still incomplete due to corruption of contactors and Govt. involvement in that as they do not take notice. He suggested making advocacy campaigns about corruption, punctuality of teachers and implementation of policies. Ikhtair Ali said bar council will provide full support in making the education free for all the children.

Discussion Highlights of the Consultation with Former Member Provincial Assembly Pakistan People's Party Parliamentarians (PPPP), Thatta

Ms. Humera Alwani MPAs (PPPP) and Mr. Uzer Jan (Journalist) said that the situation of education is very worst and they will try to address all issues in educational system in their constituency highlighted by the I-SAPS. They also asked for the proposal and to provide the information about closed school and sub standard or missing of facilities in schools.

They appreciated to I-SAPS and said that with the close coordination and with the facilitation of I-they will personally submit the proposal about increasing quality education of district.

Discussion Highlights of the Consultation with Former WHDT Network, Makli Society Thatta

Mr. Jurio Burfat said that the issues highlighted by I-SAPS are of utmost importance and the politicians have not played their role in this regard very well. Mr. Aziz Sarwan said that mentioned facts and figures are acceptable and they accept and agree to work for the betterment of education in the district. Mrs. Raheema Paanhwar said that SPO is seeking for a strong group in district Thata and now that they got that in the shape of I-SAPS, so they would like to contribute and like to see SPO & I-SAPS as partners. All the rest of the participants agreed to provide their full support for implementing the Citizen Agenda/
